In August, 2015, Monroe County Hazard Mitigation Planning Team began the process of updating the 2011 Multi-Jurisdictional Hazard Mitigation Plan which will reach its five year expiration date in February 2017. The plan update, funded by the Pre-Disaster Mitigation Grant, will highlight natural, manmade, and technological hazards that impact the county annually. We would like to invite you or your designee to join us for a presentation on the 2016 Multi-Jurisdictional Hazard Mitigation Plan on Wednesday, March 9, 2016 at 6:00 pm at the Monroe County Public Safety Center in Snydersville.

The planning group, comprised of the county, municipalities, other agencies and utilities, has selected a list of potential hazards that impact the County. In the 2016 Plan, four new hazards have been profiled - drowning, disorientation, invasive species, and terrorism. A list of mitigation measures was developed to eliminate or reduce the negative impact of these hazards on life, property, and the environment.

In order to receive federal disaster funding during or after a presidentially declared disaster, each County and Municipality is required under the Federal Disaster Mitigation Act of 2000 to have a current and adopted Hazard Mitigation Plan. The Monroe County Hazard Mitigation Planning Team has updated the Plan for Monroe County and will present their completed update to the public.
