# **CDBG Overview**

#### CDBG 101 What is CDBG?

The Community Development Block Grant (CDBG) is an annual grant from HUD (The Department of Housing & Urban Development) to localities and states to assist in the development of viable communities. These viable communities are achieved by providing principally for persons of low- and moderate-income:

- Decent housing
- □ A suitable living environment
- Expended economic opportunities



# CDBG PROGRAM OVERVIEW

#### **CDBG Program Activities**

There are a wide range of more than 20 activities that are eligible under the CDBG Program. Grantees are free to select those activities that best meet the needs of their communities. However, in order to ensure that the primary objective of the CDBG Program is met – the benefit to –low and moderate-income persons – grantees must ensure that all activities meet a National Objective:

- Benefit low- and moderate-income persons
- Aid in the prevention or elimination of slums or blight
- Meet a need having a particular urgency (urgent need) that the grantee is unable to finance

Grantees must be able to show that every CDBG-funded activity fits into one of these categories.

By regulation, at least 70% of funds must be allocated to programs benefitting low/moderate income persons annually.

## **CDBG - OVERVIEW**

#### **Eligible Activities**

- CDBG can support a variety of project types.
- Projects must benefit low- and moderate income individuals living in Monroe County and meet the needs of the community.
  - However, the regulations make the funding complicated to use.

#### **Four Primary Funding Categories:**

- Public Service
- ➤ Public Facility or Infrastructure Improvements
  - ➤ Economic Development
    - ➤ Housing

# CDBG - Overview

Public Services:	Direct, quantifiable social service delivery to eligible clients. Category capped per regulation – 15% of funding

## CDBG – OVERVIEW

#### Public Facility Improvements: Improvements to publicly-owned facilities and

infrastructure such as streets, playgrounds, and underground utilities, and buildings owned by non-profits that are open to the general public.

Activities eligible under this category include (but are not limited to):

- ☐ Rehabilitation or construction of a neighborhood community center
- Rehabilitation o construction of a homeless shelter
- ☐ Rehabilitation or construction of facilities serving persons with disabilities
- ☐ Improvements to public libraries
- ADA modifications at public facilities
- ☐ Installation of broadband infrastructure

## **CDBG - OVERVIEW**

#### **Economic Development:**

Activities to foster economic opportunity, including microenterprise and small business development, commercial and industrial development, and job creation, job retention, and job training activities.

Activities eligible include:

- ☐ Technical assistance programs and workshops for small businesses
- ☐ Grant programs for small businesses
- ☐ Business district façade improvement programs

## **CDBG - OVERVIEW**

**Housing:** activities to foster safe, affordable housing opportunities for

low/moderate income households.

Activities eligible include:

- ☐ Housing rehabilitation programs
- ☐ Energy efficiency & weatherization programs
- ☐ Acquisition & site improvements for housing.

#### LOW & MODERATE INCOME BENEFIT

In order for a project or program to qualify for CDBG funds, 51% of the program beneficiaries must meet low and moderate income as defined by HUD.

## PROGRAM REQUIREMENTS

CDBG funds are federal funds, therefore, there are a number of significant Federal Overlay Statutes, which must be followed in order to comply with federal requirements. Some of these are:

- ❖70% of funds must benefit low-to moderate income persons.
- \*Only 18% of CDBG funds can be used for administrative purposes in any proposed program
- **♦** ALL activities must be eligible for funding and meet a National Objective
- Survey Methodology (Census or Sampling)
- **❖**Citizen Participation Requirements
- ❖ Fair Housing, Equal Opportunity, Handicapped Accessibility
- Procurement and Conflict of Interest
- Environmental Standards
- Testing (Lead and Radon)
- Labor Standards (Davis Bacon)
- Section 3
- Financial Management
- Reporting and Monitoring
- Recordkeeping and Closeout
