

PUBLIC NOTICE: Hearing FFY2025 CDBG Application Revision

THE COUNCIL OF THE BOROUGH OF EAST STROUDSBURG, PENNSYLVANIA, will hold a public hearing on **Tuesday, May 19, 2025**, 7:00 pm in the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg, Pennsylvania, 18301.

The Council of the Borough of East Stroudsburg requests a revision to the FFY 2025 CDBG Application, as required by the Department of Community and Economic Development. Proposed changes include removing Park Street from the current activity until a survey can be completed for area income eligibility. The CDBG 2025 application will now include only paving improvements to Walnut and West Broad Street in the Borough of East Stroudsburg.

This hearing is being held to inform the Borough residents about the proposed changes for the CDBG FFY 2025 application. Interested residents can discuss the proposed revisions, present their views, and submit comments. Borough residents may also comment on the Borough's prior uses of CDBG funds.

The proposed revisions are on file at the Redevelopment Authority of the County of Monroe, 701 Main Street Suite 502, Stroudsburg, PA 18360, and are available for public examination between 8:30 am and 4:30 pm, Monday through Friday or by contacting Jennifer Petersen at director@monroecountyda.org or by phone at 570-421-4300. Review of the proposed revision, **and all public comments, must be submitted by Monday, May 18, 2026. The Council of the Borough of East Stroudsburg will consider approval of the CDBG FFY2025 application revisions during their meeting on Tuesday, May 19, 2026 at 7:00 pm** at the Borough Council Chambers of the Municipal Building, 24 Analomink Street, East Stroudsburg.
