1. INTRODUCTION

Monroe County Correctional Facility, a county correctional institution located in Stroudsburg PA, is soliciting proposals from qualified and licensed providers to deliver comprehensive drug, alcohol, and behavioral health counseling services to incarcerated individuals.

The Facility seeks evidence-based, trauma-informed, culturally competent programming designed to reduce substance use disorders (SUD), improve mental health outcomes, reduce recidivism, and support successful community reentry.

2. BACKGROUND

The Facility houses approximately 230 incarcerated individuals at this time, with a capacity of 430 inmates including male/female pretrial and sentenced populations. A significant percentage of the population has diagnosed or suspected substance use disorders and co-occurring mental health conditions. Services provided under this RFP must comply with applicable standards including, but not limited to:

- American Correctional Association (ACA) Standards
- National Commission on Correctional Health Care (NCCCHC) Standards
- Substance Abuse and Mental Health Services Administration (SAMHSA) best practices
- All applicable state licensing and regulatory requirements

3. SCOPE OF SERVICES

The selected Contractor shall provide comprehensive substance use and behavioral health services including, but not limited to:

3.1 Treatment Services

- Individual counseling
- Group therapy (CBT, trauma-informed care)
- Addiction Awareness
- Relapse prevention programming
- Co-occurring disorder treatment

3.2 Specialized Programming

- Gender-responsive programming
- Trauma-informed services
- Reentry relevant court ordered curriculum

3.3 Crisis Intervention

- Substance-related crisis response
- Suicide risk assessment and coordination with mental health staff for aligned response
- Emergency clinical support

4. STAFFING REQUIREMENTS

- The Contractor must provide qualified, licensed personnel including:
- Licensed Clinical Social Workers (LCSW)
- Licensed Professional Counselors (LPC)
- Certified Advanced Alcohol and Drug Counselors (CAADC)
- Minimum- Requirements:
- All clinical staff must maintain active state licensure.
- Background checks and facility clearances required.
- Experience in provision of clinical services in a drug and alcohol setting required.
- Experience working in correctional or forensic settings preferred.
- Cultural competency and trauma-informed care training required.

5. SERVICE DELIVERY REQUIREMENTS

- The Contractor shall:
- Provide services four (4) days per week, six (6) hours per day.
- Provide staffing sufficient to deliver services for approximately fifty (50) to seventy-five (75) clients.
- Maintain documentation in accordance with HIPAA and correctional policy.
- Participate in interdisciplinary team meetings.
- Track performance indicators including:
- Program enrollment and completion rates
- Reentry referral outcomes

6. PERFORMANCE METRICS

- The Facility will evaluate contractor performance based on:
- Treatment engagement rates
- Program completion rates
- Consistent services delivery
- Stakeholder feedback

7. DATA COLLECTION AND REPORTING

- The Contractor must provide:
- View access to charting documentation for clients
- Monthly service utilization reports
- Quarterly outcome evaluation reports

9. EVALUATION CRITERIA

- Proposals will be evaluated based on:

Criteria	Weight
Experience & Qualifications	25%
Technical Approach	30%
Staffing Plan	20%
Cost	20%
Reporting & Compliance	5%

- The Facility reserves the right to conduct interviews and request best and final offers.

10. CONTRACT TERM

- Initial contract term: 1 year with 2, 1 year renewals
Renewal options: Cost proposals for additional terms will be listed with % increase for each additional term.

11. INSURANCE AND LIABILITY

- The Contractor must maintain:
 - General Liability Insurance
 - Professional Liability Insurance
 - Workers' Compensation (statutory limits)
 - Certificates of insurance must be provided prior to contract execution. Levels of coverage must meet minimum threshold amounts set by Monroe County.
- Contractor shall carry General Liability Insurance, Professional Liability Insurance with limits of \$ 1,000,000 per occurrence and \$ 2,000,000 aggregate, naming County of Monroe as additional insured. Proof shall be provided via a certificate of general liability. Workers' compensation insurance shall be required. If subcontractors are utilized, Contractor will provide certificates for each of the subcontractors under the same terms as the Contractors own insurance, naming County of Monroe as additional insured on all the certificates.

 - PREA (Prison Rape Elimination Act)
 - HIPAA regulations
 - ADA requirements
 - All facility security policies
