## **Emergency Response Preparedness**

• Three (3) hazmat responses since last meeting

- o 2/11 Propane truck rollover; up-righted without incident
- 3/5 East Stroudsburg high rise fire
- 3/11 Pocono Mtn assisted with MVA; truck hit construction vehicle resulting in 10 gal fuel spill

# **OEM DIRECTOR COMMENTS**

- April Commissioners meeting signed contract with Eagle Response Service effective 5/1 however Datum will remain primary until 5/31.
- Approved hazmat books were purchased then PA State sent 20 books so LEPC has 50 books available.
- PEMA has working group for Act 165 amendments. Updates will include Tier2 fee increases.
- HMRF grant for 2024/2025 includes getting updated foam for the foam trailer (\$4825)
- HMRF grant for 2025/2026 has \$6046 allocated use for hazconnect
- HMDP grant provided \$10k for commodity flow study and hazmat conference for education.
  - Seven springs conference in August
  - Hazmat conference June 12-15

# **MODERN GAS STUDY**

- Study presented for 1400gal propane spill/leak that occurred at their Tannersville facility in December 2024.
  - Multiple corrective actions were determined and implemented including providing gas monitors to local FD and providing training for monitors. They will also get involved with LEPC
  - It was suggested to provide the corrective action list to other neighboring propane companies to prevent similar issue – this is being considered by Modern mgmt
